Fire and EMS Report: There was a total of 201 calls for the month of July. Staffing is going well. We have two (2) new interns from Frederic.

Camp Grayling is putting on a firework show at dusk on August 12, 2021 over Lake Margrethe.

Camp Grayling to make an amendment to the camp contract by \$10,000 for the Rescue Boat and Training. The rescue boat is going to be funded by Camp Grayling approx. \$14,000.00 for training and gear.

The Fire Department purchased 12 Thermal Imaging Cameras with lanyards for approx. \$9,000.00 for our fire trucks.

The Fire Department had ALS and BLS Inspector come to check all certs and ambulance. EMS Agency inspection passed.

Motion was made to Adopt Resolution No. 2021-8-A 2021 Crawford County Hazard Mitigation Plan. Motion was made by Friedman second by Dawson. Roll call vote Dawson-aye, Friedman-aye, Gabriel-aye Siwecki-aye. Motion carried with four (4) ayes and zero (0) nays.

Parks and Recreation: The next Parks and Recreation meeting will be held September 13th, 2021 at the Frederic Library.

Zoning Enforcement: Nothing at this time.

Old Business: We would like to recognize Girl Scout Angel O'Dell at our next meeting for her donation of money for a park bench for our park.
