Treasurer's Report: Motion was made to approve the Treasurer's Report. Motion was made by Siwecki and second by Richardson. Motion carried with four (4) ayes and zero (0) nays.

Supervisor Report: We applied for the \$144,996.00 that is available for Frederic Township from the American Rescue Plan.

July 17,2021 at the Eagle Park the Music Festival Committee is having 2 bands 7:30p.m.-10:30p.m. entry is by donation at the entrance.

Trustees: A citizen asked about our recycling program and if there is anyway that we could do 24 hour recycling like Otsego County does.

Building and Zoning Department: Zoning collected \$100.00. Building collected \$2,731.00. Marijuana Licenses brought in \$10,000.00.

Fire and EMS Report: There was a total of 197 calls for the month of June. There have been 48 Camp Grayling calls since they have started out there this summer.

The Fire Department is purchasing a Rescue Boat with motor and trailer for \$3,000.00 from Otsego Lake Township.

The Fire Department would like us to consider using the American Rescue Plan money that we applied for towards three (3) Auto Pulse CPR boards at aprox. \$16,000,00 each as well as three (3) new X series monitors at aprox. \$30,000.00 each.

Parks and Recreation: None at this time.

Zoning Enforcement: Zoning Enforcement has six (6) cases closed out and nine (9) open cases at this time.

Old Business: None at this time.

New Business: None at this time.

Public Comment: There is a citizen complaint of a mess that was left when a trailer home was taken down on Manistee Street. There is also question and concern on the alley between Old 27 and Manistee street being blocked.

We have one of our citizens working on new Welcome to Frederic signs since our old one was falling apart. She came and showed us a sketch of her plans.
